The intent of this list is for use by certified building departments wherever the OBC and RCO require the testing, inspection, labeling or grademarking of materials or assemblies. Whenever a certified building department receives a report from a laboratory or inspection agency or is required by this code to check for labeling or grademarking, the building department must review this list to determine if the report, label or grademark is from one of the recognized bodies listed herein. The contents of this listing to the Administrative Code are not adopted material but is recognized by the Board of Building Standards and provided as a reference for users.
