IF YOUR APPLICATION IS NOT RECEIVED IN OUR OFFICE 7 DAYS PRIOR TO TESTING DATE, YOU MAY NOT BE SCHEDULED TO TAKE THE EXAM.

IF YOU ARE A NON-RESIDENT OF OHIO YOU MUST COMPLETE THE IRREVOCABLE CONSENT TO LEGAL SERVICE FORM. A GOVERNMENT ISSUED ID IS REQUIRED THE DAY OF TESTING.

YOU MUST SUPPLY YOUR OWN REFERENCE MATERIAL. THIS WILL BE A TWO PART EXAM AND YOU WILL BE GIVEN THREE HOURS TOTAL TIME TO COMPLETE BOTH SECTIONS. THE EXAM WILL BEGIN PROMPTLY AT 1:00 P.M. YOU MUST PRESENT A PHOTO ID TO BE SEATED FOR THIS EXAM.
