All individual certification exams will be held at the State Fire Marshal's Office located at 8895 East Main Street, Reynoldsburg, Ohio 43068 (unless otherwise noted with a city). Please refer to the directory located in the lobby for the appropriate training room.

You will be scheduled for the exam upon receipt of your completed application and appropriate fees. Seating for the exam is limited and in many cases walk-ins cannot be accommodated. If your application is not received in our office 7 days prior to testing date, you may not be scheduled to take the exam.

* Our office will be under construction which might create parking issues, please be sure to arrive early.
