All individual certification exams will be held at the State Fire Marshals Office located at **8895 East Main Street, Reynoldsburg, Ohio 43068**. (Unless otherwise noted) Please refer to the directory located in the lobby for the appropriate training room.

You will be scheduled for the exam upon receipt of your completed application and appropriate fees. Seating for the exam is limited, so plan to apply early. If your application is received in our office **14 days prior to testing date**, you will receive a confirmation letter with the date and time you are scheduled to take the exam.

All Applicants must complete and return **Declaration Regarding Material Assistance** form. If you are a non-resident of Ohio, complete the Irrevocable Consent to Legal Service form.
