All exams will be held at the State Fire Marshal's office located at **8895 E. Main Street Reynoldsburg, Ohio 43068**. A government issued photo ID must be presented the day of exam. Please refer to the directory located in the lobby for the appropriate testing room.

You will be scheduled for the exam upon receipt of your completed application and appropriate fees. If you are a non-resident of Ohio, you must complete the irrevocable consent to legal service form. Your application must be received in our office 7 days prior to testing date in order to be scheduled to take the exam. **Walk-ins cannot be accommodated.** The test center has a maximum capacity of 25 seats. Due to limited seating, if we are at capacity when we receive your application, you will be scheduled for the next available exam date.

You must supply your own reference material. This will be a **two-part exam** and you will be given **three hours total time to complete both sections**. **The exam will begin promptly at 1:00 p.m.**
